## **Zoning District Boundary Changes**

#### C-2 to RH-1

Part of the NW ¼ of the NW ¼ of Section 1, T.5N., R.10E., Town of Rutland, and part of the SW ¼ of the SW ¼ of Section 36, T.6N., R.10E., Town of Dunn, Dane County, Wisconsin, described as follows: Beginning at the Northwest corner of Section 1; thence S00°14′W along the West line of the NW ¼ of the NW ¼, 533 feet; thence S89°46′E, 285 feet; thence N00°14′E, 533 feet to the North line of the NW ¼ of the NW ¼; thence S89°40W along said line, 130 feet; thence N69°57′W, 101 feet; thence S89°40′W, 56 feet to the West line of the SW ¼ of the SW ¼ of Section 36, Town of Dunn; thence South, 33 feet to the Southwest corner of said ¼ - ¼; thence West, 8 feet to the point of beginning. Containing 3.6 acres more or less.

#### C-2 to A-1EX

Part of the NW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  and the SW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$ , all in Section 1, T.5N., R.10E., Town of Rutland, Dane County, Wisconsin, described as follows: Commencing at the Northwest corner of Section 1; thence South along the West line of the NW  $\frac{1}{4}$ , 533 feet to the point of beginning; thence continue South along said West line and the West line of the SW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$ , 1788 feet more or less to the Southwest corner of the SW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$ ; thence East along the South line of said  $\frac{1}{4}$  -  $\frac{1}{4}$ ; thence North along the East line of the SW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  and the NW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$ , 2350 feet more or less to the Northeast corner of said  $\frac{1}{4}$  -  $\frac{1}{4}$ ; thence West along the North line of the NW  $\frac{1}{4}$  of the NW  $\frac{1}{4}$ , 1035 feet more or less; thence South, 533 feet more or less; thence West, 285 feet more less to the point of beginning.
