Majority <u>X</u> AUTHORIZING BADGER RD LEASE FORJOINING FORCES FOR FAMILIES & THE **COMMUNITY RESTORATIVE COURT PROGRAM – CYF DIVISION**

Policy Analysis Statement:

Brief Description of Proposal -

Dane County Department of Human Services is involved in a program of providing more localized services in the communities identified as needing those services most. Two such programs are the Joining Forces for Families (JFF) Program and the Community Restorative Court (CRC). The JFF and CRC programs are renewing a lease in a building owned by Centro Hispano located at 810 W. Badger Rd, Madison. This resolution is to pay for the monthly rental payment of \$1,050 per month to cover costs related to occupying this space during the lease term of twelve months (12/01/17 running through 11/30/18).

Current Policy or Practice -

Leases require County Board approval.

Impact of Adopting Proposal -

The Dane County Clerk and County Executive are authorized to execute the described lease on behalf of DaneCounty. The JFF/CRC office space will be utilized by a Dane County community social worker, the CRC Coordinator and a new CRC social worker. The total rate for the term period is \$12,600. All utilities except electricity and telephone will be paid by Centro Hispano. There is no increase in the amount of rent. There are two oneyear renewals included in the lease.
