Motion by Ripp, seconded by Mireles, to approve the minutes of the June 22, 2017 CDBG Commission meeting. Motion carried unanimously by a voice vote.

The Minutes were approved.

2018 FUNDING RECOMMENDATIONS.

Attachments: Initial Funding Recommendations

Motion by Ripp, seconded by Mireles, to approve the 2018 funding recommendations as presented. The motion was open for discussion.

Ripp summarized the funding recommendations and reasons for funding based on the Application Review Team interviews.

Shea commented that using CDBG funds for the Gorman and Company rental development project is taking money away from other CDBG projects that were not fully funded. She noted that the value of the grant per unit of affordable housing was higher for Gorman than for the other two rental projects.

Motion by Shea, seconded by Amegashie, to amend the funding recommendations (amendment #1) by reducing funding for Gorman to \$350,000 and distribute the extra \$100,000 as follows:

Habitat \$20,000

Movin' Out (mortgage) \$15,000 Project Home (major) \$15,000 Latino CC \$10,000 Sunshine Place \$20,000 Vera Court \$10,000

Independent Living (minor) \$10,000

Upon further discussion, Stechshulte stated that the site has been designated as blighted by the City of Sun Prairie and contains a potentially serious contamination issue that is preventing the site from being utilized, adding that the site lies within one of the more problematic census tracts in the City. He continued by stating that Sun Prairie has some of the worst workforce housing in Dane County outside of Madison, and this development will target renters with incomes between 30-60% AMI, while increasing the tax base for the City and creating positive economic implications for the area. Shea noted that unknown contaminants may be problematic to the environmental review process and could potentially prevent the project from moving forward, adding that it may be more appropriate for the local municipality to pay for the remediation. Solberg mentioned that the Commission should keep in mind how fast organizations spend their money, noting that the County's timeliness ratio is measured at the end of each year, and that there are several organizations in the proposed amendment that still have outstanding balances from prior year contracts.

Ripp added that affordable rental housing is the highest priority area for the County, and the Gorman project not only addresses affordable rental housing but also eliminates a contaminated site and will help spur economic activity in Sun Prairie.

Motion to adopt proposed amendment #1 failed by a voice vote.

Motion by Amegashie, seconded by Oberle, to amend the funding recommendations by moving the unallocated \$17,031 to Independed Living's Minor Home Repair proposal (amendment #2). Motion opened for discussion.

Johnson pointed out that this project ranked 14th out of 15 on the scoring of proposals. Mireles noted that WWBIC scored first out of all projects, yet only received 75% of their request. They also garnered support from the public, with all 6 of the written public comments submitted expressing support of WWBIC's proposal.

Motion by Oscar, seconded by Stechschulte, to amend the funding recommendations by moving the unallocated \$17,031 to WWBIC's proposal (amendment #3). Motion

opened for discussion.

Amegashie stated that WWBIC's need for financial assistance of CDBG funds is not as high as many of the other proposals, noting that they are a statewide program and receive funding from several other sources.

Motion to adopt amendment #3 failed by a voice vote.

Discussion was re-opened for amendment #2.

Shea stated her concern about ILI in that they consider themselves a contractor for the County by providing a service for the County outside of their normal scope of services, and therefore the administrative costs are proportionally high compared to other comporable projects. Ripp agreed with Shea's points, but added that they perform good work and without our funding those services would be gone. Amegashie stated that Sunshine Place is getting a major loan through a bank, and \$17,031 is not going to make or break their public facility project.

Motion to approve amendment #2 by allocating the additional \$17,031 to ILI failed 5-3 (Amegashie, Johnson, and Ripp voting in favor).

Motion by Oberle, seconded by Shea, to amend the funding recommendations by moving the unallocated \$17,031 to the Sunshine Place public facility proposal (amendment #4). Motion passed by a 6-2 vote (Ripp and Amegashie voting against).

Discussion was re-opened for main motion, as amended.

Motion by Mireles, seconded by Shea, to amend the funding recommendations by reallocating \$6,486 in public service funds from Sunshine Place to the Tenant Resource Center (amendment #5). Motion passed by a 6-2 vote (Ripp and Solberg against).

Vote on the main motion to approve the 2018 funding recomendations, as amended twice (amendments #4 and #5), passed by a voice vote.
