DANE COUNTY CONDITIONAL USE PERMIT # 2393

THE ZONING AND LAND REGULATION COMMITTEE OF THE DANE COUNTY BOARD PURSUANT TO SECTION 10.255(2) OF THE DANE COUNTY CODE OF ORDINANCES DOES HEREBY:

GRANT Conditional Use Permit # 2393 for a <u>Limited Family Business</u> pursuant to Dane County Code of Ordinance Section 10.192 and subject to any conditions contained herein:

EFFECTIVE DATE OF PERMIT: October 25, 2017

THE CONDITIONAL USE SHALL BE LOCATED ON THE PROPERTY DESCRIBED AS FOLLOWS:

ADDRESS: 7097 County Highway P, Town of Dane, Dane County, Wisconsin

PARCEL # 0908-221-9960-0

Legal Description:

Lot 1 of Certified Survey Map 10717, T09N R08E, Town of Dane, Dane County, WI

CONDITIONS:

- 1. Conditional Use Permit #2393 shall be for operation of a contractor's business with a wood working shop and storage of recreational vehicles.
- Sanitary fixtures shall be permitted in the accessory structure for the contractor's office purposes. Sanitary fixtures shall be removed or terminated upon the expiration of the conditional use permit.
- 3. All materials and equipment used in the operation of the business shall be stored within the accessory building.
- 4. The accessory building shall not be used for residential purposes.
- 5. Hours of operation of the business shall be limited to 5am-10pm daily.
- 6. No business signage shall be permitted.
- 7. The Conditional Use Permit shall expire upon sale of the property to an unrelated 3rd party.

THE ZONING AND LAND REGULATION COMMITTEE AFTER PUBLIC HEARING AND IN THEIR CONSIDERATION OF THE CONDITIONAL USE PERMIT MADE THE FOLLOWING FINDINGS OF FACT:

- 1. That the establishment, maintenance and operation of the proposed conditional use will not be detrimental to or endanger the public health, safety, morals comfort or general welfare.
- 2. That the uses, values, and enjoyment of other property in the neighborhood for purposes already permitted will not be substantially impaired or diminished by the establishment, maintenance, and operation of the proposed conditional use.
- 3. That the establishment of the proposed conditional use will not impede the normal and orderly development and improvement of the surrounding property for uses permitted in the district.
- 4. That adequate utilities, access roads, drainage and other necessary site improvements will be made.
- 5. That adequate measures will be taken to provide ingress and egress so designed as to minimize traffic congestion in the public streets.
- 6. That the proposed conditional use does conform to all applicable regulations of the district in which it is proposed to be located.

EXPIRATION OF PERMIT

In addition to any time limit established as a condition in granting this CUP, Section 10.25(2)(n) of the Dane County Code of Ordinances provides that any use for which a conditional use permit has been issued, upon its cessation or abandonment for a period of one year, will be deemed to have been terminated and any future use shall be in conformity with the ordinance.
