# JOINING FORCES FOR FAMILIES PROGRAM - DCDHS - CYF DIVISION

### Policy Analysis Statement:

# Brief Description of Proposal -

Dane County Department of Human Services is involved in a program of providing more localized services in the communities identified as needing those services most. One such program is the Joining Forces for Families (JFF) Program. The program is renewing a lease on office space in a building owned by Cyrena Pondrom and managed by the Investment Planning Corporation and this space is located at 2225 Allied Drive, Apartments #1,2, 3 and 4, Madison, Wisconsin. This resolution is to pay for the monthly rental payment of \$2,840 per month to cover costs related to occupying this space during the lease term of twelve months (01/01/18 to 12/31/18).

# Current Policy or Practice -

Leases require County Board approval.

#### Impact of Adopting Proposal -

The Dane County Clerk and County Executive are hereby authorized to execute the described lease. The negotiated rental rate for the designated JFF space is presently below market at \$710 per month for one unit. The space will be utilized by a Dane County Community social worker and other JFF partners. The total rate for the term period is \$34,080. All utilities except electricity will be paid by landlord.
