THIS AGREEMENT is between the County of Dane, by its Department of Public Works, hereinafter referred to as "COUNTY", and Badger Materials Recycling, LLC., 612 N Sawyer Rd., Oconomonwoc WI., 53066, hereinafter called the "VENDOR".

### WITNESSETH

WHEREAS, COUNTY has secured services for a project described as follows:

## Recycling of Shingles from Dane County Landfill Site #2

WHEREAS, VENDOR and COUNTY, by a separate document, Purchase of Services Agreement #11629 (hereafter, "Agreement"), did on October 8, 2013 enter into a contractual relationship pursuant to which VENDOR is to provide services in the recycling of up to 5,000 tons of shingles from Dane County Landfill Site #2 annually, and,

WHEREAS, VENDOR and COUNTY wish to amend the Agreement in order to extend the original contract, and,

WHEREAS, the Agreement allowed for pricing changes in 2018 and beyond.

**NOW, THEREFORE,** in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- 1. The Agreement shall remain in full force and effect unchanged in any manner by this amendment except as changes are expressly set forth herein. This Amendment shall control only to the extent of any conflict between the terms of the Agreement and this Amendment.
- 2. The Agreement shall be extended until September 30, 2019.
- **3. ARTICLE 4,** of the agreement is amended by adding the following:

### **Schedule B: Cost Schedule-Payment**

Clean Shingle Loads: \$12.00 / ton

Mixed Shingle Loads: \$24.00 / ton
