
Our law firm was recently retained to represent New Cingular Wireless PCS, LLC ("AT&T") in connection with the above-referenced CUP application. The most recent staff report on file for this application notes that a 2013 state law imposes certain limitation on the County's authority to regulate the siting of mobile service towers and requires the County to act on applications within 90 days unless there is an agreement to extend the deadline. The staff report indicates that Dane County has requested an extension to allow County staff, its tower consultant and the Town of Rutland additional time to review the pending application.

I am authorized to inform you that, Pursuant to Wis. Stat. § 66.0404 (2)(d), AT&T has agreed to extend the deadline for action on the pending application until January 31, 2018.

On behalf of AT&T, we look forward to working with Dane County, its consultant and the Town of Rutland in the weeks ahead to deliver additional information confirming that the proposed tower complies with applicable state and local laws.
