Policy Analysis Statement:

Brief Description of Proposal -

The proposal relates to the acceptance of grant funds and creating a 1.0 FTE Specialized Resource Prosecutor position within the Dane County District Attorney Office for a third year. The position will carry a specialized Domestic Violence (DV) and Sexual Assault (SA)caseload and be a resource for Region 2, within the State of WI, that includes 18 counties related to sensitive crimes.

Current Policy or Practice -

In the third year of the Specialized ADA grant, there will be a continued focus on a sensitive crimes caseload to include Domestic Violence and Sexual assault cases and to continue to be a resource for Region 2.
