Public Safety Assessment (PSA) in Milwaukee County and Money Bail: Judge Jeffrey Kremers

Pretrial Concepts

- *Most low risk, nonviolent offenders cannot afford money bail*
- *Pretrial Justice goals: protect the public, assure court appearance, and preserve legal and constitutional rights afforded persons awaiting trial*
- *Risk-Based Approach: measuring risk (risk to public and risk of failure to appear in court) and managing risk*
- *Monetary bail improves court appearance rates for higher risk defendant, but does not improve rates in for low risk defendants and can have negative consequences*
- *Monetary bail for low risk defendants can increase recidivism and does not improve community safety*
- *When held for 2-3 days, low risk defendants almost 40% more likely to commit new crimes before trial than equivalent defendants held no more than 24 hours*

Public Safety Assessment and Decision Making Framework

- *Pretrial Risk Assessment: objective, research based instrument that uses risk factors to predict likelihood of success/failure for released defendant pending case disposition*
- *Milwaukee developed a tool to determine threat of defendant based on FTA (failure to appear) and NCA (new criminal activity) with action points*
- *82% adherence rate with bail type recommendation based on tool*
- *65% pretrial release rate, 76% appearance rate, more than 95% safety rate (less than 5% committing new crimes, less than 1% committing new violent crimes)*

2. MacArthur Safety and Justice Challenge

MacArthur Safety and Justice Challenge

- 40 jurisdictions involved in challenge: 20 implementation sites and 20 innovations sites*
- Dane County is an innovation site, working with Community Restorative Courts*
- Safety and Justice Challenge working on continuing and potentially increasing work with innovation sites, providing technical assistance*
- Convening in New Orleans: diverse areas represented, many criminal justice stakeholders present*
- Next steps: continue Dane County criminal justice system improvements, increase transparency, track data, and engage Safety and Justice Challenge national technical assistance providers*

One-Year Report: Amended Rule 206, Earlier Initial Bail Review Hearings

- Presented by Judge Colás*
- Rule 206 amended July 1, 2016, to provide automatic, prompt bail review hearings or initial appearances for persons booked into jail*
- Median time from booking to hearing: 48.42 hours (down from 65 hour median, 26% reduction)*
- 82% who had a hearing were released immediately, the rest had monetary bail*
