The DCDHS Children Youth and Families Division (CYF) currently employs a .9 FTE senior social worker to fulfill the role of independent living coordinator (ILS). This position works with youth aged 14 or older who will soon age out of the foster care system. The additional ILS hours are needed to meet additional responsibilities. The additional responsibilities include extension out of home care and supervised independent living which were not initially considered as part of the ILS responsibilities after the State restructured ILS. The long tenured employee in this position has preferred to work a less than full-time position. With her impending retirement, DCDHS has the ability to increase the position to a 1.0 social worker.
