1. Lyle Fund Update – Badger Prairie Health Care Center

D. Presentations

1. Family Care Roll Out Update Todd Campbell, Adult Community Services Administrator

CAMPBELL provided update on transition of existing MA Waiver funded adults (Developmentally Disabled, Adults with Physical Disabilities and Frail Elders) to the new Family Care Programs. Reported that ADRC is ahead of schedule with options counseling but slightly behind on confirmed February enrollments. CAMPBELL also provided update on work being done by case management agencies to transfer client related care plans, documents, etc to receiving MCO entities to ensure a smooth transition as much as possible. CAMPBELL overall impression is that transition process has been going as well as it can given the number of persons who will be enrolling into new programs over the next four months.

2. Expansion of Adult Protective Services Unit in 2018 Todd Campbell, Adult Community Services Administrator

CAMPBELL reported that due to the expansion of Family Care into Dane County additional funding will be received from Department of Health Services as historically there is an uptick

in the work done by Adult Protective Services (APS) and Elder Abuse when Family Care is established. CAMPBELL reviewed the new staffing structure within APS – 6.0 FTE within Guardianship services and 7.0 FTE within Elders and/or Adults at Risk investigations.
