APPROVAL OF ASSIGNMENT AND AMENDMENT OF LEASE E / DCRA 96-12 INVOLVING LAND AT THE DANE COUNTY REGIONAL AIRPORT

Policy Analysis Statement:

Brief Description of Proposal -

RMD Corben, LLC is requesting Dane County's approval of an assignment of Dane County Lease No. Lease E - DCRA 96-12 from RMD Corben, LLC to PERTCO LLC for the office building and land it resides on adjacent to the Dane County Regional Airport. This request for transfer is required and provided for under the lease. As a condition of Dane County's approval of the lease assignment the County has requested amendment of lease provisions regarding the description of the premises, permitted uses, term clarification, approval of improvements, subordination, condemnation, and party addresses.

Current Policy or Practice -

RMD Corben, LLC leases land and owns an office building adjacent to the Dane County Regional Airport under Dane County Lease No. Lease E -DCRA 96-12. Payment of rent under Lease E is current, and all other obligations thereunder have been fulfilled. Dane County approves reasonable requests for lease assignments when the present lessee is not in default.

mpact of Adopting Proposal -

Lease E - DCRA 96-12 is assigned to PERTCO LLC and becomes financially obligated to make payments to Dane County. Under this assignment, the terms and conditions set forth in the lease remain largely unchanged, with the exception that Dane County has requested amendment of lease provisions regarding the description of the premises, permitted uses, term clarification, approval of improvements, subordination, condemnation, and party addresses.
