1. Activity Report

Director Livingston reported that in January activity was up 3 percent and year to date enplanements were up 3 percent, as well. Seats are up 20 percent over last year. Projected seat capacity for the summer indicates that positive growth should continue.

2. Air Park Matters

Deputy Director Jones reported positive tenant activity including potential new building projects and new lease holders. She added that the tenants will have to come to the commission for approval on the projects as the antiquated covenants and subcommittee are no longer in effect. There was some discussion and positive feedback.

3. Possible Revision of Chapter 15 of the Dane County Code of Ordinances

Director Livingston deferred to Supervisor McCarville who mentioned that the Ordinance Amendment revision to Chapter 15 of the Dane County Code of Ordinances work is still in progress and any updates that would affect this body will be brought to the Commission.

4. Landside Construction Update

Deputy Director Jensen briefed the commission on the history of the Employee Parking Lot and the plan for expansion to 370 stalls and a new cell phone lot. Jensen handed out a map which highlighted the runway protection zone. The expansion and update will include gating, fencing, new and improved lighting and will be safer for employees. Construction should begin early April of this year. Discussion ensued.
