- a. In 2017 RSVP transported 87,756 home-delivered meals and provided 14,716 medically related rides, compared to 84,438 meals and 14,615 rides in 2016. Remarkably 654 volunteer drivers, compared to 677 drivers in 2016, provided this transportation. The number of meals delivered and rides provided continues to increase from year to year as total volunteer drivers decline. RSVP focuses on serving the elderly and veterans.
- b. RSVP provided 1,348 dialysis rides compared to 2,498 rides in 2016. The decline in rides was directly related to 3 clients whom discontinued transportation service. Total dialysis rides are limited to provide service for other types of medical appointments. As the aging population grows the demand for dialysis rides will increase drastically.
- c. Approximately 20 to 25 riders traveled on each of the Bus Buddy Excursions in 2017, compared to 10 to 15 riders in 2016. This popular program trains groups of seniors to use Metro Transit. The group travels by bus to a city event and lunch as they learn to use mainline bus. Most participants are low income and depend on Metro Transit for transportation. Attached is the Excursion Bus Buddy training schedule for 2018.
