C. Action Items

1. ADVOCACY SUPPORTING FEDERAL & STATE PROGRAMS

Committee members discussed the President's 2019 FY Budget Proposal and the FY 2018 Omnibus Spending Bill, which was signed by the President. Although the spending bill includes increased funding for many senior adult programs, the senior adult population and yearly inflation is increasing. As a result, funding for Older Americans Act (OAA) programs is actually decreasing and the 2018 Federal budget understates the losses of flat funding whereby we have less funding per capita.

A motion was made by SCHMIDLKOFER, seconded by KAUD, to ask the State of Wisconsin to provide fiscal data to show the effects of flat funding in relation to inflation and population growth since 2010 on OAA funding through 2018 with projections to 2025, which has and will have a negative effect on Dane County aging programs funded through OAA. The motion carried by the following vote:

ADRC GOVERNING BOARD

Schmidlkofer explained the history of the Council and that it advises the Office on Aging on issues affecting senior adults throughout Wisconsin.
