#### D. Site inspections for the April 26, 2018 Public Hearing

1. Appeal 3691. Appeal by Coyle Inc. (Bill Rupp, La Crosse Sign Group, agent) for variances from maximum allowable height and minimum setback from right-of way for an on-premise pylon sign as provided by Sections 10.74(19) and 10.83(1), Dane County Code of Ordinances, to permit alteration to existing sign at 250 West Beltline Highway (US Highway 18-151) being part of Lot 3, Block 2, W.H. Jacobs and E.S. Barker's Subdivision in the SW 1/4 NW 1/4 Section 36, Town of Madison.
2. Appeal 3692. Appeal by Jeremiah Duerst for a variance from minimum required setback to right-of-way as provided by section 10.17(1)(b), Dane County Code of Ordinances, to permit an addition to an existing agricultural heifer barn at 560 State Highway 92 being located in the NW ¼ of the NW ¼, Section 25, Town of Primrose.
