1. National League of Cities - Reducing Jail Populations Debrief

2. Sequential Intercept Model Debrief

Clark discussed the McAurthur Safety and Justice Challenge and provided background on Policy Research Inc (PRI). A video related to the Safety and Justice Challenge was shared. Participants commented that the experience helped build common knowledge, highlighted the need for mental health provider participation and revealed that Dane County is a resource rich community. PRI is scheduled to produce a report in February.
