*Frazier announced the board will conduct two public hearings regarding the County's transition to Family Care on May 15 at the Alliant Energy Center. He encouraged board members to attend the sessions, scheduled for 10:30 am to 1 pm and 5-7:30 pm. Invitations will be issued to the following Dane County officials: Joe Parisi, County Executive; Lynn Green, Director of Human Services; Sharon Corrigan, County Board Chair, Jenni Dye, County Board Supervisor; and Jeremy Levin, County Board Supervisor.*

*Frazier distributed two Milwaukee County ADRC documents produced following similar hearings – a list of recommendations to the Wisconsin Department of Human Services and a summary of comments from the listening sessions. Dane County ADRC Manager Jennifer Fischer will make publicizing the hearings a priority and will solicit written comments from consumers who cannot attend a hearing. Recommendations and consumer feedback will be shared with county and state officials.*

## G. ADRC Manager's Report

*Fischer summarized a presentation regarding the transition to Family Care by Dane County Department of Human Services officials -- including Lynn Green, Director; Bill Hanna, Division Administrator; Jean Kuehn, Manager of Planning and Evaluation; and Edjuana Ogden, Budget Contracts and Operations Manager -- at a joint meeting of the Health and Human Needs Committee and the ADRC Governing Board. Requests for Proposals will close May 15 and the announcement of contracts with managed care organizations is expected in July. IRIS consultant agencies will not be awarded contracts, but can gain certification to serve any region of the state.*

*Fischer will confirm the date of the next joint meeting, likely in July, and share the information with board members.*
