## a. 2017 Project Summary

The 2017 TIP project utilized the Design Thinking Process to design prototypes that would assist individuals with developmental disabilities and other disabilities when arranging their transportation needs. In 2017 the guide "Quick Reference: Transportation Provider Options in Dane County for People with Developmental and Other Disabilities" was developed.

# b. 2018 Project

The 2018 TIP project plans to design additional prototypes: transportation planning guide and training curriculum, self-assessment tools, a plan for early and ongoing transit education and Navigation assistance when customized transit solutions are needed.

## 1. Employment Transportation Assistance Program

a. The ETA Program provides eligible individuals a 31 Day bus pass to seek employment. Dane County was able to contact 80% of the job seeker participants for calendar year 2017 and 75% of these seekers successfully found employment. Cumulatively, years 2014 through 2017, Dane County was able to contact 84% of job seeker participants and 75% of these seekers successfully found employment. The success rate of the ETA program is consistently high. STC requested future data to include job seeker age and ethnicity.
