2. Update on Keys to Dignity, Long Term Storage Efforts

Public Comment:

Ronnie Barbett from Sanctuary, Inc. spoke of the storage needs among people experiencing homelessness. He has some ideas on possible long-term storage sites and will share them at the next committee meeting.

Representatives from the Friends of the State Street Family reported on the progress on the Keys to Dignity Program. James Reeb Church has been identified as a first site for the lockers. Friends of the State Street Family hopes to expand the locker sites.

Staff reported that more partners are being phased-in to provide services at The Beacon, including CAC housing navigation service, MACHOne Health, MEDIC, RISE parent child home program, Catholic Charities' mental health services, Urban League life skills and employment training. Forward Services will expand the employment services. Catholic Charities was approved for three VISTA volunteers for The Beacon.

The County developed a Tenant Screening Worksheet as a new addition to the Affordable Housing Fund Development RFP. More specific language on using the community's by-name list was added to the County RFP.
