AMENDMENT TO LEASE

WHEREAS, Sherman Plaza, Inc. as Lessor and The County of Dane as Lessee entered into that certain LEASE variously dated 4/14/17 and 6/5/17 leasing to Lessee approximately 1,800 square feet within the building located at 2830 Dryden Drive, Madison, Wisconsin, and
