# **Policy Analysis Statement:**

# Brief Description of Proposal -The Village of Dane has requested the Dane County Sheriff's Office provide additional police service within the boundaries of Village of Dane, at a level above and beyond the basic level of police service currently provided. The Village of Dane has agreed to compensate Da ne County for the cost of assigning certified sworn law enforcement officers, to perform law enforcement service at approximately 20 hours per week; vehicle and office space will be supplied by the Village. The potential annual revenue is estimated at \$75,390. Current Policy or Practice -Contracts must be approved by the County Board and executed by the County Executive. Impact of Adopting Proposal -Providing law enforcement service to a community is an essential service that is costly, especially for small municipal governments. Purchasing policing service is less costly when compared to the cost of operating a municipal police department or establishing a new police department. The Dane County Sheriff's Office can provide high level, cost effective service and policing efficiency to the community.
