AUTHORIZING ACCEPTANCE OF GRANT FUNDING TO PURCHASE PRELIMINARY BREATH TESTING EQUIPMENT

## **Policy Analysis Statement:**

#### Brief Description of Proposal -

The Wisconsin Department of Transportation, Bureau of Transportation Safety (BOTS), is making funds available for the purchas e of Preliminary Breath Testing (PBT) equipment, Grant Number FG-2018-DANE CO-04419, grant period October 1 through September 30, 2018. Grant funding of \$4,000 will allow for the purchase of PBTs to replace and supplement current equipment inventory and will be used for traffic stops or incident where alcohol use is suspected; new units will be used for grant enforcement as well as routine patrol.

### Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

# Impact of Adopting Proposal -

Driving and drinking continues to be a problem in Wisconsin. The Sheriff's Office patrol enforcement team increases public safety on roads and highways by detecting and removing impaired drivers. The purchase of PBT equipment for patrol vehicles will provide tools for Deputies to test suspected impaired drivers effectively and effectively thereby assisting in reducing alcohol related crashes, injury, and fatalities.
