

INNOVATION

The Community Restorative Court (CRC) will utilize restorative justice principles to divert young adults (17-25), who have committed a low-level offense, from the traditional criminal justice system.



County Population: 509,939

Jail Capacity: 1,013

ACHIEVEMENTS

- Expanded the CRC and trained 41 new peacemakers.
- 94% successfully completed their repair harm agreement.
- Held Community Service Project fundraising event for restitution fund.
- Conducted community engagement activities to build knowledge on restorative justice efforts and the CRC.
- With Code for America, implemented a text messaging reminder system.
- Conducted Innovation Competition for Tech -Heroes and selected TimeBank to produce informational videos on restorative justice and the CRC.






The Public Safety Assessment (PSA)



RICH DATA THUS FAR USING THE PSA

- Data set: May 2017-March 2018: Residents in jail custody
- The average age at arrest is approx 34 years old. The majority of defendants (2,935) are non-Hispanic or Latino (~94%), 184 (5.87%) defendants have Hispanic or Latino ethnicity.






Data Driven Justice (DDJ)

Counties are developing strategies to address two key populations that drive jail populations:

- "Frequent utilizers"
- People held in jail before trial because they cannot afford to bond out, not because they are a risk to the community or a risk of flight.



County Culture Matters: Achieving better outcomes through data driven improvements

Collaboration with Partners

All members of the CJC are strong collaborative partners and have been KEY to moving forward with DATA.

Create a culture and capacity for data-based decision-making and continuous evaluation and improvement.

CJC, County Board of Supervisors, MPD, and Fountain of Life Church—host Implicit Bias and Racial Anxiety seminars.

City of Madison, Community Partners, National League of Cities technical assistance—reducing cities use of jails.





Strategic Development

Over 40 professionals from Dane County worked together to develop a comprehensive strategy to divert people with mental illness from the criminal justice system. Partnering with national experts, Policy Research Incorporated (PRI), Dane County mapped current resources to help identify additional opportunities for community-based solutions for criminal justice-involved people with mental illness. Using the "Sequential Intercept Model" (S.I.M.), Dane County will identify points of contact to intervene, provide resources, and prevent individuals from entering or moving deeper into the criminal justice system. Strategic plans will be developed in the next six months.
