#### 2. CCR Updates:

- Child Abuse & Neglect: None
- Intellectual Disabilities: Pomije reported that the new supervisor started last week. The CCR is looking for members interested in serving and requested that people send recommendations to her.
- Domestic Violence: Barry reported that Judge Mitchell came to the last meeting to participate in a conversation about restraining orders. The Abuser Treatment Monitoring Committee is holding an event on Friday, October 19, 5:30-7:30, at Pasquale's. Howe added that the Legal Issues Subcommittee held a discussion about DV certified programs for treatment.
- Elder Abuse: Gray-Dorn gave update on CCR and FAST.
- Sexual Assault: Thornley-Parisi reported that the SA CCR is working on making sure students can access accommodations through Title IX rights. Deaf Unity will be presenting about services and barriers that people face. 50% of deaf children are sexually assaulted.
