AUTHORIZING JOB CENTER OFFICE AND SOUTH MADISON OFFICE SPACE SHARING AGREEMENT BETWEEN DANE COUNTY DEPARTMENT OF HUMAN SERVICES AND FORWARD SERVICE CORPORATION - EAWS DIVISION

## **Policy Analysis Statement:**

#### Brief Description of Proposal -

Beginning January 1, 2018 through March 31, 2018, Forward Service Corporation will lease thirty four (34) standard cubicle workspaces and five (5) standard sized private offices within the Dane County Human Services Job Center building located at 1819 Aberg Avenue, Madison, Wisconsin. Beginning April 1, 2018 Forward Service Corporation will lease twenty-six (26) standard cubicle workspaces and five (5) standard sized private offices within the Dane County Human Services Job Center and also three (3) standard cubicle workspaces within the South Madison Office located at 2306 South Park Street, Madison, Wisconsin.

#### Current Policy or Practice -

Leases require County Board approval.

#### Impact of Adopting Proposal -

This resolution authorizes the rental agreement and revenue of \$7,558.20 per month for January through March 2018 based upon 39 workspaces at a per workspace rate of \$193.80. For April through September 2018, monthly revenue will be \$6,732 per month for 34 workspaces at a per workspace rate of \$198.00. Thereafter, monthly revenue will be \$2,772 to cover costs related to occupying 14 spaces during the lease year of 01/01/18 to 12/31/18. The total rate for the term period is \$71,382.60.
