# Approval to update conflict of interest policy

In regard to commissioners applying for Cultural Affairs grant funding. Williams-Maclin noted that most boards have a similar policy in place. Albouras requested that the full commission receive ample time to draft and finalize this language.

Motion for approval to develop a code of conduct policy for the Cultural Affairs handbook. The drafted code of conduct policy will be presented to the full commission. The handbook committee will welcome feedback from the full commission on appropriate code of conduct language.

Approval to move foward with adding the word "Art" to Dane County Cultural

Motion to move forward with the director creating a resolution to have the word "Art" added to Dane County Cultural Affairs.

Approval to fund cycle 1 proposal %25 after discovering scoring error- Beween the Waves

Executive committee voted to approve the Between the Waves project 25% of their request due to a panelist scoring error. The panelist missed entering a score. Director noted that two individual artists that were awarded did not accept grant funds, due to the projects not being able to continue with limited funds. The funds that were not accepted are still available in the grants —in-aid line item. Veldran suggested asking grant recipients if the percentage awarded is useful to the project.
