C. Action Items

1. PAUL H. KUSUDA SPECIAL PROJECTS FUND GRANT

AAA Manager Cheryl Batterman stated the family of Paul H. Kusuda made a donation of \$2,000 to the Special Projects Fund following the longtime AAA Board member's death. Grant rules stipulate the money must be spent in 2018 on unmet needs within the Senior Focal Point's Case Management Program. Focal Point directors suggested using the funds to help purchase computer tablets to assist case managers while working with clients in the community. Nine Focal Points requested funds for use in purchasing a tablet.

A motion was made by BARMAN-PAULSON, seconded by LEIGH, to divide the \$2,000 donation equally among the nine Focal Points who requested funds for use in purchasing a computer tablet. The motion carried by the following vote:

Dane County Supervisor Tanya Buckingham delivered the first outreach session promoting the County Board's new initiative "Engage Dane." Over the next six months, the Board will be going through four major phases to gather feedback and implement new and innovative approaches to engaging with residents of Dane County. The phases include soliciting input about how the community wants to be engaged, development of a plan based on community input, reviewing the draft plan with interested community members and the County Board, and implementation of a pilot plan. AAA Board members offered verbal feedback and completed a survey rating the effectiveness of engagement approaches.

E. Reports to Board

1. STATE & FEDERAL REPORT

Neal Minogue, Supervisor of the Wisconsin Bureau of Aging and Disability Resources' Office on Aging, reported the agency submitted its aging plan to the Administration for Community Living on 26 June. Feedback is expected within the next 30 days.

Minogue stated AAA staff should receive feedback on its 2019-2021 AAA Area Plan draft goals by the end of July.

2. BOARD MEMBER REPORTS

3. CHAIR & STAFF REPORTS

Batterman reported the Dane County Board of Supervisors will consider the reappointment of Supervisors Veldran and Williams and community representatives Barman-Paulson and Kretschman for another term on the AAA Board during its meeting on 12 July. In addition, Supervisors Nikole Jones and Richard Kilmer are expected to be appointed to the AAA Board to replace Supervisors Clausius and Downing, who reached their term limits.

Batterman reported AAA staff continue work on the 2019-2021 AAA Area Plan as they await feedback about the draft goals from the Wisconsin Bureau of Aging and Disability Resources.

AAA Aging Program Specialist Angela Velasquez reported she will submit a proposal written in conjunction with AAA Board Member Sridevi Mohan and DCDHS Adult Protective Services Manager Beth Freeman for a \$1 million Administration for Community Living grant entitled "Alzheimer's Disease Programs to States and Communities" on 11 July. The funding would enhance services to dementia-afflicted seniors who live alone, would facilitate earlier assessment and care-plan execution for developmentally disabled seniors, and would expand dementia crisis work in Dane County.

Velasquez reported planning is underway for a regional Senior Nutrition Program Site Managers Training in September. Presentations about opioid abuse, suicide prevention, and food safety are scheduled.

Velasquez reported the entire \$165,000 in National Family Caregiver Support Program funding is projected to be distributed by the end of July. Grants are in the amount of \$1,000 this year, up from \$750, with the goal of creating a more significant positive outcome for caregivers. Additional grants could become available via carryover funding when the final 2018 federal budget numbers are provided.
