 - 1. Stormwater Volume Trading Program Work Group discussion with members of the Capital Area Regional Planning Commission
 - Jeremy Balousek, Dane County Land & Water Resources Discussion of Stormwater Volume Pilot Project

With new Act 243 legislation, the Stormwater Volume Trading Program Work Group recommends a pilot project to provide actual cost information for a fee-in-lieu of trading program. Balousek presented several ideas for a pilot explaining that the infiltration volume for each would be easily quantifiable. Ideas included:

- a) The TAC partner with Dane County Parks on cropland conversion. This is one of the best and probably most economical types of volume control projects. Balousek suggested cropland conversion might cost approximately \$500/acre for seed and maintenance. A 40-acre project would cost approximately \$20,000. He presented a map from the Parks Division which suggested 5 potential sites for a stormwater volume control pilot project. (McCarthy, CamRock, Anderson, Falk Wells and Walking Iron). Map is provided in report file that follows.
- b) Partner with Dane County Land & Water Resources on projects they are already doing and add a stormwater volume control. This could include:
- •Roof runoff over farm feedlots (could divert to an infiltration pond)
- •Farm stormwater basins to reduce speed of water and gully erosion
- •18 grassed waterways
- •8 acres of harvestable buffers
- •2 wetland restorations

c) Use the 2019 Urban Water Quality Grant Program to expand cost sharing for municipal rain gardens. There seems to be a lot of interest by municipalities to get involved. Balousek mentioned a rain garden report that City of Monona did. This report is provided in the report file that follows.

b. Work Group Discussions of Next Steps

Work group thought it was best to identify "shovel ready" projects and agreed that cropland conversion might be the easiest to do. They agreed that it would be good to have a pilot that could serve as a demonstration project that documents costs and credits for a certain type of volume control practice.

In order to do a cropland conversion project on Dane County park land, the Parks Division would need to approve, and it is possible that leases would need to be broken. There is precedent for that and the acreage for a pilot are small.

If the LWC stormwater pilot budget recommendation (\$100,000) is approved, TAC suggests a blend of projects: e.g. 150 acres of cropland conversion on park land (\$75,000) plus a \$25,000 rain garden pilot grant program.
