IN SUPPORT OF THE WILLIAM S. MIDDLETON MEMORIAL VETERANS ADMINISTRATION HOSPITAL AND IN OPPOSITION OF PRIVATIZATION OF SERVICES

- 4 Dane County area Veterans Administration clinics and hospitals currently see
- 5 approximately 1349 patients daily. Of those, the William Middleton Memorial Veterans
- 6 Administration Hospital in Madison currently sees about 951 outpatients daily. Services
- 7 provided include medical, surgical, neurological, psychiatric, and a range of outpatient
- 8 services as well as research programs in clinical, basic, laboratory, rehabilitation, and
- 9 health services research.
- 10 Affiliated with the University of Wisconsin School of Medicine and Public Health, and
- physically connected to the University of Wisconsin Clinical Science Center, the hospital
- and its affiliated clinics provide world-renown care and research to the thousands of
- veterans that utilize its services supported by a \$385.6 million budget.
- 14 This critical area hospital and clinics employ approximately 2,200 employees making it an
- integral part of the Dane County economy and community. The services provided to
- veterans and the jobs created are unmatched and should not be compromised by a
- potential transition to private care providers.
- 18 The federal government needs to support policies and provide resources that do not
- 19 jeopardize care for veterans by moving essential resources to the private sector. The
- 20 diverse group of veterans that utilize the services of the VA include older residents with
- 21 diseases associated with aging and disabilities associated with past wars, and younger
- veterans with complex conditions related to their military service.
- 23 Discussions of privatizing the Veterans Administration federally have been underway for
- 24 many months by the current federal administration. Advocates for privatizing believe that
- 25 services should be pushed to the private sector rather than reinvesting in the department.
- 26 Privatization for very rural areas without reasonable access to Veterans Hospitals and
- 27 services has been advocated for by Veterans and their organizations for several
- 28 years. The current federal administration has moved from providing private services in
- 29 very rural areas toward complete privatization rather than reinvesting in the department
- 30 which lowers the quality of care for the majority of Veterans.
- 31 Veterans care should not be seen as a political pawn, rather a requirement and duty to take
- 32 care of the men and women that served this country. Dismantling a system that is
- 33 supported and preferred by 80% of veterans so that a small group of people can profit is
- irresponsible and negligent.
- 35 NOW, THEREFORE, BE IT RESOLVED that the Dane County Board of Supervisors
- 36 supports and recognizes the significance of the William S. Middleton Memorial Veterans
- 37 Administration Hospital and area clinics in the lives of veterans and in the Dane County
- 38 community; and

- 39 **BE IT FURTHER RESOLVED** that the Dane County Board of Supervisors opposes the
- 40 privatization of services that the Veterans Administration provides to millions of veterans
- 41 nationally and thousands of Dane County residents jeopardizing their care; and
- 42 **BE IT FINALLY RESOLVED** that a copy of this resolution be sent to the Dane County
- 43 legislative delegation, Governor Scott Walker, Representative Mark Pocan, Representative
- Paul Ryan, Senator Tammy Baldwin, Senator Ron Johnson, and President Donald Trump.
