AUTHORIZING EXECUTION OF AN AIR SERVICE PROMOTION AND MARKETING AGREEMENT FOR SUN COUNTRY AIRLINES -DANE COUNTY REGIONAL AIRPORT-

Policy Analysis Statement:

Brief Description of Proposal -

Under Dane County Regional Airport's Air Service Promotion and Marketing Agreement, the airport will provide up to \$100,000 for marketing assistance towards Sun Country Airlines new non-stop air service between Madison and Tampa, FL (TPA), and Madison and Fort Myers, FL (RSW). In addition to marketing assistance, DCRA will provide a waiver of landing fees for Sun Country flights arriving non-stop from TPA and RSW for twenty-four months from the initiation of direct service.

Current Policy or Practice -

The Airport's Community Air Service Support Program offers marketing assistance and fee waivers to airlines offering new non-stop service from Madison to certain market destinations. The Airport currently has no direct airline service from Madison to Tampa or Fort Myers. The fixed term promotional support and landing fee waiver is similar to that previously made available to other airlines under the Program.

Impact of Adopting Proposal -

Non-stop service to TPA and RSW will offer convenience and time savings to passengers whose final destination is the Tampa and Fort Myers area.
