Youth Homelessness Demonstration Program

YHDP

Extent of Youth Homelessness in Madison/Dane County

- 2018 January PIT
 - Out of 614 total persons identified as "literally homeless", 5 unaccompanied youth under age 18; 39 youth age 18-24
 - Usually undercounted
- 2017 Annual Homeless Assessment Report
 - Out of 2,996 total persons who stayed at ES and TH, 327 (11%) were youth age between 18-24

What is YHDP?

- HUD's new initiative to reduce the number of youth experiencing homelessness
- FY 2016: \$33 million awarded to 10 communities
- FY 2017: \$43 million awarded to 11 communities
- FY 2018: \$ 80 million to be available for 25 communities

What does YHDP Offer

- Funding between \$1 million and \$15 million
- 2-year grant terms
- Some programs renewable through the HUD CoC grant process
- Opportunity to implement new and innovative project models
- Technical assistance in planning and implementing the Coordinated Community Plan (CCP)

Eligible Programs

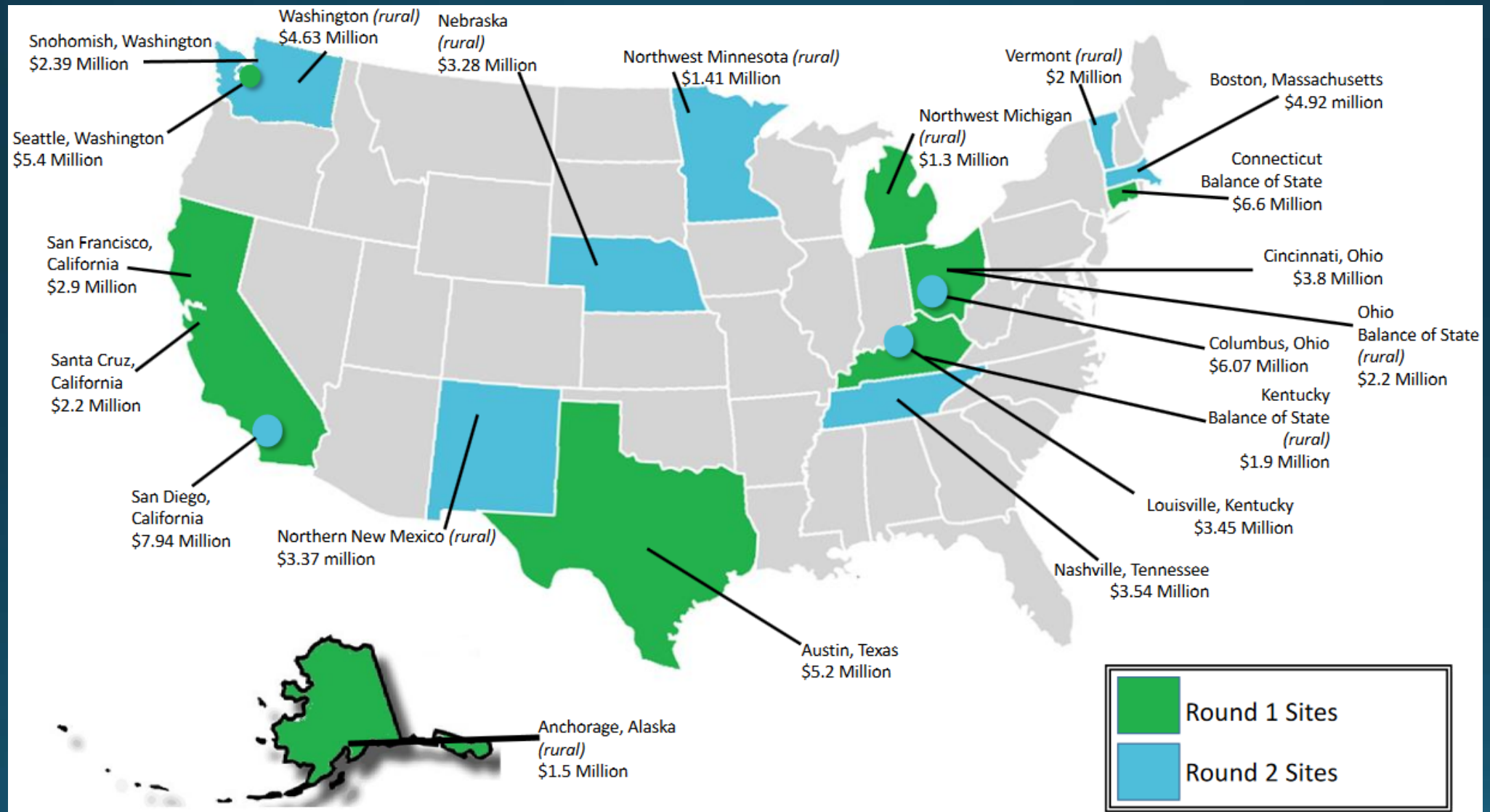
A. Already Eligible Programs under 24 CFR 578.37

- Planning
- Permanent housing, including PSH and RRH
- Transitional housing, including crisis residential housing
- HMIS
- Supportive services only, including coordinated entry, housing search and placement services, case management, drop-in centers, street outreach

Eligible Programs (cont.)

- B. Fundable and renewable without a waiver
 - Host homes and kinship care: subsidize the increased costs to the family, needs to be CoC eligible costs such as food
 - Shared housing: rent assistance
- C. Fundable and renewable with a waiver
 - RRH 2.0 : longer term or sponsor-based rental assistance
 - Transition aged youth rental assistance (up to age 25)

Communities awarded YHDP



What YHDP Requires

- To bring together a wide variety of stakeholders
 - Housing providers, local and state child welfare agencies, schools, workforce development, the juvenile justice system, etc.
- To assess the needs of special populations
 - Racial and ethnic minorities, LGBTQ+ youth, parenting youth, youth in foster care and juvenile justice systems, and victims of human trafficking
- To create a Coordinated Community Plan
- Must confer with the CoC's Youth Action Board (YAB) about the application

What would it take to bring this to us?

- **Leadership Capacity**20 pts
Need to identify a lead agency to coordinate the effort
- **Collaboration**.....20 pts
Support from stakeholders –child welfare agency, public housing authorities, law enforcement, affordable housing developers, nonprofits, etc.
- **Financial Resources**..... 10 pts
Ability to fund the development of a coordinated community plan (8 month budget) and operate a system. 25% match requirement.
