#### **RESOLUTION R-179-18**

#### AUTHORIZATION TO ACCEPT AN INTERGOVERNMENTAL AGREEMENT AS A BACKUP DANE COUNTY EMERGENCY OPERATIONS CENTER

This Intergovernmental Agreement ("Agreement") is made by and between Dane County ("County"), the City of Fitchburg ("City"), pursuant to § 66.0301, Wis. Stats., to be effective as of October 9, 2018.

WHEREAS, the City is currently in the process of establishing an Emergency Operations Center (hereafter, "EOC") located at Fire Station No. 1, 5791 Lacy Road, Fitchburg, Wisconsin; and

**WHEREAS,** the County currently has an existing EOC located in the Dane County Public Safety Building, 115 W. Doty Street; and

WHEREAS, both the City and the County need a location for a back-up EOC; and

**WHEREAS**, County has funding available to provide communications and other technology necessary to operate a functional EOC at Fire Station No 1; and

**NOW, THEREFORE, LET IT BE RESOLVED** that, pursuant to Wis. Stat. §66.0301, the parties do mutually agree as follows:

- MUTUAL EOC BACK-UP LOCATIONS. The County will allow the City to use the existing primary County EOC in the Dane County Public Safety Building as a back-up City EOC location. The City will allow the County to use the newly created primary City EOC in the Fitchburg Fire Station No. 1 as the back-up County EOC location and training room.
- 2. DURATION. The term of this Agreement shall continue indefinitely, subject to termination of agreement as set forth in section 6.
- 3. DESIGN AND CONSTRUCTION OF FITCHBURG FIRE STATION NO. 1 EOC LOCATED AT 5791 LACY ROAD, FITCHBURG, WISCONSIN.
  - a. The City shall enter into a contract for design, construction and implementation of the remodeling of Fitchburg Fire Station No. 1 at the City's cost.
  - b. Prior to construction the City will consult with the County regarding the design of the space for the EOC. County shall have input over the design, and shall have the right to terminate this Agreement prior to the start of construction if the parties cannot reach an agreement on the design of the EOC.

c. County will provide, at its own expense, communications equipment and other needed technology set forth on Exhibit A to be used at the Fire Station No. 1. County shall procure and install the equipment at its cost. Said equipment will remain the property and responsibility of County. Either party shall have the right to terminate this Agreement prior to the start of construction, if the parties do not reach a mutual agreement regarding necessary equipment and installation.

# 4. USE OF CITY EOC FACILITYAT FITCHBURG FIRE STATION NO. 1.

- a. The City shall retain all ownership and control over the building including the EOC facility and shall be responsible for building maintenance and upkeep. The City will have the right of first use (with the exception of backup EOC emergency use).
- b. County Emergency Management shall have primary use of the EOC facility if needed as backup for emergency operations. The County may use the facility for training. Use of the space will be scheduled through the Fitchburg Fire Department to prevent double booking the room.
- c. When not needed by County for emergency operations, City may use the facility for training or any other operational needs, including a regional training site.

# 5. USE OF COUNTY EOC FACILITYAT DANE COUNTY PUBLIC SAFETY BUILDING,

- a. The County shall retain all ownership and control over the building including the EOC facility and shall be responsible for building maintenance and upkeep. The County will have the right of first use (with the exception of backup EOC emergency use).
- b. City Emergency Management shall have primary use of the EOC facility if needed as backup for emergency operations. The County may use the facility for training. Use of the space will be scheduled through Dane County Emergency Management to prevent double booking the room.
- c. When not needed by City for emergency operations, County may use the facility for training or any other operational needs, including a regional training site.


## 6. TERMINATION.

•

- a. Either party may terminate this Agreement for any reason upon 75 days' notice to the other party in writing.
- b. If the Agreement is terminated by either party, County will have the right to remove all property provided by County as listed on Exhibit A that is not a fixture to the building.

## 7. LIABILITY.

- a. All parties, each and for itself, shall be responsible for any injuries, claims or losses arising from or caused by the acts or omissions of it agents or employees acting within the scope of their employment, in accordance with Wis. Stats. §§ 893.80 and 895.46(1).
- b. County and City will carry insurance needed for protection of their own property. Each party assumes the financial liability and responsibility for their own equipment.
- c. This agreement is not intended to create any contractual liabilities or causes of action by either party against the other party.
- 8. ENTIRE AGREEMENT AND AMENDMENTS. The entire Agreement of the parties is contained herein and this Agreement and Exhibit(s) supersedes any and all oral agreements and negotiations between the parties relating to the subject matter hereof. The parties expressly agree that this Agreement shall not be amended by any fashion except in writing, executed by the parties.
- 9. NO THIRD PARTY RIGHTS. This is an Agreement between the parties, and nothing herein creates any rights in any third person.
