**D. Presentations****1. Violence Prevention Coalition Effort - Jarrett Jones, Data Analyst, PHMDC**

*Jarrett Jones distributed information about Community Safety Intervention Team (CSIT) that is being formed to address violence prevention and intervention efforts. The City has allocated a substantial amount of money for peer support specialists to work with the violent crime unit of the Madison Police Department. Jones invited members to attend the Violence Prevention Coalition on November 29 at the MPD Training Facility, 10 a.m. -2 p.m. He reviewed the next steps.*

*Amy Brown discussed the No Hit Zone Initiative. Kato mentioned the Parenting Inside Out program for prisoners and LINKS sponsored forum on African American mental health. Scarr suggested that Jones connect with the VA.*

**E. Reports to Committee****1. Legislative Update/Announcements:**

- CCR's should submit their annual report summarizing their work for 2018 to Chair Murray.
- Election of the new COSC chair will occur at the January 2019 meeting.
- No COSC meeting in December.
- McCarville reported that the County budget is completed and it addresses environment, roads, public safety, affordable housing, youth programming, criminal justice reform streamlining, etc. The full budget is on the Dane County website. Jail issues are also being addressed. She noted that County taxes are reduced by 1%.
- Thornley-Parisi noted that Education Secretary Devos introduced a bill that would drastically reduce the effectiveness of Title IX which affects high school and middle school as well as college students. Proposed changes would deter people from coming forth to report sexual violence. See RCC website for public comment time.
- Winter reported that she will transition off of the Commission in January due to change in job duties. Kat Riley will head SVU starting in July. A human trafficking detective was approved in the budget starting in July.

**2. CCR Updates:**

- Child Abuse & Neglect: Kato reported that the 7th Annual Trauma Informed Community Summit attracted 300 participants. The CYF Consortium is restructuring to include youth justice. The next meeting is November 27, 1-2:30 at Rainbow. The next CCR meeting is December 4.
- Intellectual Disabilities: Pomije reported that the CCR heard a presentation on IRIS benefits. Presentations on a variety of topics are set up through August 2019.
- Domestic Violence: Barry reported that they heard a presentation from JFF. The subcommittees are wrapping up work for the year. Court watch is summarizing data to present early next year.
- Elder Abuse: Scarr reported they are planning for 2019. They discussed Elder Justice Task Force initiatives. She alerted members to a phone scam asking for SSN's for SSA benefits increase or saying benefits would be cut off.
- Sexual Assault: Sathasivam reported that the next meeting is in January. They are working on ways to help school staff respond appropriately to sexual assault and endorsements for victim bill of rights. Miyasaki reported that Commercial Sexual Exploitation of Children (CSEC) is working on a public awareness campaign and DPI approved curriculum called "I empathize" for middle school and high school.
