AUTHORIZING ACCEPTANCE OF FUNDS FROM THE FY 2018 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM

Policy Analysis Statement:

Brief Description of Proposal -

Request authorization to accept grant funds from the FY 2018 Edward Byrne Memorial Justice Assistance Grant Program in the a mount of \$21,530 to be used as follows: \$5,780 to the Sheriff's Office for forensic video lab improvements; \$10,500 for the Dane County Drug Court Treatment Program; and \$5,250 for the Dane County District Attorney Crime Response Program. The City of Madison will administer the grant funds.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

The Sheriff's Office has outgrown its existing lab space for digital evidence examination and has designated an alternate new location to meet current needs. Grant funding of \$5,780 shall provide for the purchase and installation of acoustic tile and lighting to improve the new space allowing for scientific examination, comparison, and evaluation of evidence, and will allow the Sheriff's Office to collaborate with other law enforcement officers and the District Attorney's Office during evidence examination.
