## D. Presentations

## 1. Deferred Prosecution Unit of the District Attorney's Office

Presented by M. Juette

M. Juette described the Deferred Prosecution Unit in the District Attorney's Office. There is a needs assessment. There is a determination to see if pre-charge deferral is appropriate and form a contract with an individual, usually 9-36 months.

Look at Alcohol and Drug Abuse, Mental Health and Opiates assessments. There are several ways to access the opiate program. Most cases are post-charge. There is a focus on accountability and changing behavior.

If someone opts out, then they go back to court. There is a process before someone is removed from the program.

Contracts are individualized. There are opiate classes, parenting classes, African American male issues.

- . 2 substance abuse counselors
- . 1 community service coordinator
- M. Juette presented data from 2018
  - . Post-charge: These people need to sign a guilty plea
  - . Pre-charge
  - . Pre-screene Get information about contract requirements and costs.
  - . Re-referral These w/second chance to return

47% Between ages of 17-25

Question: How to measure success?

There has not been analysis regarding recidivism

There is a program fee, but is accessed on a sliding scale.

Discussion Ensued regarding Biggest Challenges

- . Accountability if someone needs treatment and cannot afford it.
- . Reliable transportation (Are bus cards available)
- . Mental Health issues
- . Trauma with so much going on, it is hard to figure out where to start

#### Parisi suggested:

- . United Way coordinated an initiative re-paying health insurance premiums
- . Make sure to have the resources list from DHS
- . What is the success rate? Why do peopel fail to comply?

Meuer - Any occasion that individual comes from CRC then DPU

There is discussion of collaboration

Corrigan - Role of Public Defender - Can they help someone who is pre-charge? Yes. The goal is to keep the community safe.

Rusk - Additional social worker in the budget, will that help? Yes. It will particulary be useful having a bilingual person.

The quicker one get into the program, the better. The ADA needs to screen.

Clark pointed out that the CRC used text messages. That would be helpful. Ability to pay restitutions on-line would also be helpful.

Ozanne spoke of a couple of incidences of overlap with CRC. Not an ability to evaluate program.

Parisi asked how can the Council help with coordination?

#### 3. Pre-Arrest Diversion and Re-entry Summit Debrief

One action item would be to have Hamilton County to speak to the Criminal Justice/Continuum behavior health.

Ozanne - We are not complete on data. Want to know earliest point to intervene. Questions:

- . Can we create an environment of diversion?
- . Can we support a family so people not come in to system?
- . Could we intervene when kids ages 6-8 years old rather than 12-15?
- . Can data tell us earliest point to intervene?

Mahoney asked, Can we schedule a CJC meeting to talk about juvenile justice? Let us get all the players at the table. The CJC should be unified.

Parisi asked, What would you like at that meeting?

Mahoney Responds:

- . DHS
- . DA
- . Juvenile Judges

Parisi - State's involvement, Question: What do we want to achieve? Mahoney - Education of they system.
