# **Policy Analysis Statement:**

#### Brief Description of Proposal -

Request approval to accept grant funding for the Sheriff's Office to purchase night vision equipment for use in a variety of special situations that are beyond ordinary law enforcement capabilities. Applications for night vision equipment include searches for individuals in low light conditions, search and rescue efforts, and evidence recovery.

# Current Policy or Practice -

Acceptance of grants requires approval of the County Board.

# Impact of Adopting Proposal -

The Dane County Sheriff's Office requires specialized night vision equipment to enhance it's ability to intervene in high-risk events and to safely resolve these situations including VIP protection and providing assistance with arrest and search warrants.
