She also distributed a press release from the Office of the Governor-elect announcing the Next Generation Workforce and Economic Development Policy Advisory Council bringing experienced economic development stakeholders from across Wisconsin to work with the transition team on creating an economy that works for everyone.*

Topics included affordable and accessible transportation and the creation of Regional Transit Authorities; broadband; renewable energy and the workforce generated from this fast-paced sector; planning for energy infrastructure; placing greater emphasis on mental health issues; gaining a rural perspective in planning issues; and breaking down silos that exist amongst State and local government agencies and organizations working towards the same goals.*
