1. Public Health and Violence Prevention

2. CRC Updates

1. *S. Marino and Ms. Foxx presenting on the Community Restorative (CRC).*
 - a. *The CRC completed 5 Peacemaker trainings in 2018 (training approximately 125 peacemakers) and will facilitate 4 more trainings in 2019.*
2. *D. Foxx, the new LTE Program Leader will start a retail theft pilot program. This will be an education piece starting Mid December.*
 - a. *DA Ozanne asked about the length of the pilot because of the MOU, originally retail theft was not included. The questions is whether the focus should focus on more serious cases.*
 1. *There is a need to examine the MOU.*
 - b. *R. Chance asked the DA if there is a patters, is the start of a pattern of more serious cases.*
 - c. *C. Clark-Bernhardt stated that historically this would be the easiest referrals and could overwhelm the CRC.*
3. *Referrals - total 323 since the start with a 91.6% success rate. Only two cases have been declined.*
 - a. *2018 data 183 referrals to date*
4. *Gender data slightly more men (58%) than women (42%) entered into the program*
5. *Race - slightly more black (44%) than white (41%) entered into the program*
6. *Ages 17 and 18 years older are the largest group served*
 - a. *20 years old spiked in 2018*
7. *Disorderly Conduct is the largest percentage of offense referred*
 - a. *Retail Theft*
 - b. *J. Bauman asked about the data on 17-years old*
 - c. *C. Clark-Bernhardt is working on the dated on DC holds in the 17 - 25 year olds*
8. *Referrals in general has been through Madison Police (47%) and the DA's office (33%)*
 - a. *2018 has been very similar to the overall trends between City of Madison (34%) and DA's Office (37%)*
9. *MOU*
 - a. *12 agencies have signed the MOU*
 - b. *The CRC is adding Deforest, Verona and Dane County Sheriff's Office but have yet to sign*
10. *CJC has requested data on arrests (custodial and non-custodial) that could flush out what is going on in the CRC*
11. *R. Chance is also collecting data on child neglect.*
 - a. *The issue of Human Service has not shared data with the criminal justice*
 - b. *Dane County is not a leader in sharing data between systems.*
 - c. *There is a need to look at the most vulnerable families; the earlier, the better (birth to 3)*

3. Burns Institute

C. Clark-Bernhardt is using data around disparity gaps. Data on Harris County. There will be an update for the next meeting.
