Brief Description of Proposal -

The Prairie Enthusiasts (TPE) have applied to the Dane County Conservation Fund Grant Program for financial assistance to purchase approximately 4.3 acres in the Town of Vermont from the Wilken Trust for the Blue Mounds Natural Resource Area.
