In addition, to mitigate the impacts of the loss of public land, DOT will purchase approximately .2 acres of land west of Liuna Way and install a 24 foot driveway from Liuna Way across County land and adjacent Department of Natural Resources (DNR) land to the Yahara River. DOT will also construct a parking lot and a canoe/kayak launch on DNR property and coordinate with both agencies on construction, installation of signage and seeding and landscaping along the driveway.		
25 26 27 28	The DOT project was known at the time of the property purchase and it was understood and anticipated that a portion of property would be sold to DOT once the project details were known.		
29 30 31 32 33	NOW, THEREFORE, BE IT RESOLVED that the County of Dane does hereby approve and authorize the sale of the approximately 5.026 acres of land to DOT for the offered \$40,200.00 and temporary limited easements on .818 acres for the offered amount of \$500.00, and
