Policy Analysis Statement:

Brief Description of Proposal -

The Department of Human Services accepts the Wisconsin Child Abuse and Neglect Prevention Board "Bringing Protective Factors Framework to Life in Your Work" monies in amount \$5,000 and creates related revenue and expenditure lines in this Resolution.

Current Policy or Practice -

Budget changes require County Board approval.

Impact of Adopting Proposal -

These monies will support expenses related to training child and family service providers in the Protective Factors Framework. The training will consist of six, two-hour sessions for up 35 – 40 participants. The training will increase child and family service providers understanding of the protective factors needed to strengthen families with the ultimate goal to reduce the risk of child maltreatment. The training commitment is for the time period of July 1, 2019 – June 30, 2022. This is the first year of the agreement with two, one-year renewal options.
