C. Action Items

Summit Planning

Extensive discussion about the future of the Summit. Salov reported he felt the need to slow down, he was gathering support from interested parties but not hearing a lot from colleagues around the county. Are leaders too busy dealing with day to day to think about future? It was suggested that the Commission pull together an idea for the future and then pull parties together to discuss and change it. At least get them talking. There was discussion that many of these regional concepts are already being done. The landscape of EMS has changed, should we work more closely to assist with changes. How do we incentivise working together? It was suggested that we look at population growth and look at predictors for call volume. It was also suggested that the Commission go to a clean slate, erase the current system on a map and put transport units where they might be, and EMR where they might respond, look honestly at all the budgets and determine if there is a better way both fiscally and patient care driven. There was no overall consensus on the need for a consultant/outside eye to assist.

Next agenda will include looking at demographics from both 911 and EMS and look at 3, 5, and 10 years, discussion with leadership from Towns/Villages/Cities and determine 3-5 topics for summit. Agreement to have the Commission build this summit at this time.
