**2. History of Festge County Park and Salmo Pond County Park - Darren Marsh, Parks
Director**

*Marsh reported that Festge County Park is named after Otto and Evelyn Festge who
donated 16 acres on a limestone bluff overlooking the Black Earth Creek Valley in 1963.
Since then the park has grown to over 155 acres. The Park provides two shelters, a
scenic overlook, hiking trails, a play area and is within the Ice Age Trail Corridor.*

*Salmo Pond is named for the Latin word for fish in the salmon family. It is 7.5 acres and
includes access to a pond that was once used as a gravel pit, as well as access to a
world class trout stream. The park offers barrier-free access to both the pond and
stream. WDNR annually stocks the lake with trout.*

3. Friends of Festge Report

Gary Nelson, President of the Friends of Festge County Park, provided an overview of the vegetation management work along with some unique historical points related to the trees and vegetation. The restoration effort started in 2010 and phase one is nearly complete with 55 acres being restored. The Friends of Festge donate more than 4,000 hours annually to the restoration. Once the land is restored, fire will be used to maintain the oak savannah site. Work efforts include collecting prairie seed from the park, as well as from the park seed program, and planting on the newly cleared areas. The last project included raking the leaves and debris from the steep hillside to plant the seed. This friends group regularly uses Operation Fresh Start's county crews to assist with the restoration efforts. They also use other volunteer organizations. Each year students from the Chicago University donate time to help support this friends group. Nelson stated they needed more volunteer assistance and asked the county to work on new ways to recruit volunteers. He stated there are programs such as the Master Naturalist program that can greatly support our parks. He stated that both he and his son are both certified Master Naturalists.
