




### FOCUS OF ADULT PROTECTIVE SERVICES


- Assess petitions from Probate Court
- Assess referrals from the community on individuals who are alleged to be incompetent and in need of protective services or protective placement
- Prepare petitions and court reports
- Provide court testimony
- Monitor appropriateness of court orders and placements
- Assist in review of guardian conduct when needed




### **ADULT GUARDIANSHIP ASSESSMENTS**


FOCUS ELDER ABUSE / NEGLECT AND ADULTS AT RISK

- Investigate reports of individuals age 18 and older who are alleged to have experienced physical, sexual or emotional abuse, financial exploitation, unreasonable confinement, or are self neglectful and offer supportive services
- Provide a bridge to resources and ongoing support
- Do not provide long term case management










### ELDER VICTIM SUPPORT PROGRAM: AMY SCARR

### INTELLECTUAL DISABILITY SPECIALIST: CARRIE POMIJE


Assists individuals with an Intellectual Disability who have been a victim of abuse, neglect, financial exploitation and/or self neglect
