Policy Analysis Statement:

Brief Description of Proposal -

The Wisconsin Department of Justice has been awarded a federal COPS Office AHTF Grant for \$2.5 million to allocate to local multi-jurisdictional drug task forces for reimbursement of overtime hours spent on conducting heroin and opiate investigations. WDOJ is granting the Dane County Narcotics Task Force \$60,000 (\$30,000 annually), for the term of January 1, 2019 through December 31, 2020 (two years), to conduct heroin, fentanyl, and other opiate investigations. Request authorization to accept grant funding.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

Acceptance of AHTF grant funding shall advance public safety by providing funds to locate and investigate illicit activities through statewide Task Force collaboration related to the distribution of heroin, fentanyl, carfentanil, and the unlawful distribution of prescription opioids.
