# **Policy Analysis Statement:**

#### Brief Description of Proposal -

The Paradigm Foundation has donated \$104,000 to the Dane County Sheriff's Office for the purchase of specialized equipment for use in tactical encounters including active shooter or high-threat situations. Safety equipment to be purchased from the donation of the Paradigm Foundation shall increase the likelihood of law enforcement personnel and first responders survival and shall include items such as rifl e rated vests, helmets, shields, and first aid kits. Request authorization to accept Paradigm Foundation donation of \$104,000.

## Current Policy or Practice -

Acceptance of monetary donations requires approval of the County Board.

## Impact of Adopting Proposal -

Law enforcement officers and first responders require specialized equipment to deal with well trained, equipped, and determined adversary's when responding to calls in high risk situations. Equipment such as rifle rated vests, helmets, shields, and first aid kits provide protection, and can save lives or prevent injury, for both officers and civilians.
