1. Legislative Update/Announcements:

- McCarville reported that there are three new County Board members. The Board passed funding for jail.
- Thornley-Parisi explained that RCC had initially endorsed Marsy's law; however, they have rescinded support due to potential consequences to victims. - McKinney reported on Mayor Satya's listening session held at Lussier Center by invitation where black leaders discussed their frustrations and discussed better ways to approach students with mental health issues proactively.
- Susan Alan-Lee reported that Kathy Veerhusen is leaving Meriter on July 11 so the hiring process is underway. She also informed members that Brava magazine published an article about the program without having it reviewed and there were many errors. Corrections have been submitted.
- Crowley reminded members that there are three community representative positions open on the Commission. She encouraged members to send names of potential candidates to her.

2. CCR Updates:

- Child Abuse & Neglect: Kato reported that the Trauma Informed Summit is coming up and ideas are welcomed. Rhumba 4 Rainbow save the date cards were distributed (attached).
- Intellectual Disabilities: Pomije invited members to the ID CCR meeting at the ADRC today from noon-1:30. They will be hearing mental health presentations.
- Domestic Violence: No report.

 - 1) EACCR- May meeting agenda topic was Better Business Bureau presentation on Frauds and Scams.
 - 2) WEAAD- Success!
 - 3) FAST- May meeting discussion of DAIS Court Watch summary, Restraining Orders and financial crimes/exploitation; June meeting is a presentation from Legal Action- Elder Rights Project.
 - 4) HTF-2019 goals include Law Enforcement FAQ's, exploration and development of a Mobile Resource Response, explore idea of Peer Specialist/training.
 - 5) Domestic Violence in Later Life Conference planning underway.
