Policy Analysis Statement:

Brief Description of Proposal -

Dane County Department of Human Services (DCDHS), Children, Youth and Families Division (CYF) has been awarded a competitive grant from the Wisconsin Department of Children and Families (DCF) for activities designed to help retain foster parents including relative caregivers. The CYF Division engages in robust and successful foster home recruitment and retention activities and this grant award will allow the Division to enhance our efforts in critical areas especially with relative caregivers and teen foster homes.
