Policy Analysis Statement:

Brief Description of Proposal -The Department of Human Services CYF Division has a Social Worker position #1435, which we request be reclassified to a Youth Justice Coordinator. This position will be supervised by a CYF Child Protective Services Supervisor. This position has been vacant for over six months. The Department of Administration- Employee Relations has recommended approval of this request. Current Policy or Practice -Changes in position reclassification and modifying position authority require County Board approval. Impact of Adopting Proposal -This position will play an integral role in serving the 17-25 year old population throughout Dane County. This position will be primarily responsible for providing case management, program development, data tracking, collaboration and outreach for a new initiative to serve 17-25 year olds. This classification will develop and coordinate a program to engage and support individuals who have committed "low level" offenses. The future incumbent will also be responsible for communicating and collaborating with a variety of community agencies around mental health, criminal justice, AODA, housing, education and employment.
